

Step 1:

Determine the business location and obtain the required permits.

Selecting the right location for your business is crucial to its success. Every business in the City of Rosemead is required to have a Business License or a Business Registration, depending on the business classification.

The City has specific zoning requirements for different types of businesses. Prior to entering into a lease agreement or purchasing a piece of property, it is recommended that you check with the Planning Division to determine if the type of business you wish to operate is permitted within the zoning district where it is located. If your business is not permitted within the zoning district, the Planning Division can advise you of the proper zoning district(s) for your business.

When the location has been decided and the zoning has been cleared and signed off, you are ready for Step 2.

Step 2:

Complete and submit your Business License or Business Registry application.

The City of Rosemead provides two types of business certificates: Business License and Business Registration. The type of application and documentation you will be required to submit will depend on the type of services your business will provide.

Certain business classifications, like hair salons and offices, fall under the City's no cost Business Registry Program. These businesses are still required to comply with the City's rules and regulations for zoning and permits.

When you are ready to submit your application, contact the City Manager's Office at (626) 569-2105 to ensure you have all the required documents and are ready for Step 3.

Step 3:

Pay the fee and receive your business certificate.

For business classifications that fall under the Business License Program, when all required documents have been submitted and verified, the applicable business license fees can be paid in person at City Hall, or through our online web portal. Upon receiving payment and provided all processing is complete, the Business License Certificate will be issued.

Businesses classifications that fall under the Business Registry Program are not required to pay a fee. Provided that the application and required documents are complete, the Business Registration Certificate will be issued upon processing.

All issued certificates must be renewed annually from the issued date, along with a renewal fee applicable only to business license certificates.
